Where We're At

The Private Forest Accord and related legislation resulted in Forest Practices Act rules changes and ODF increasing staff capacity. This included the creation of a Training Unit and additional field forester positions. In

collaboration with subject matter experts, the Forest Resources Division Training Team developed learning materials and conducted training opportunities for ODF foresters, operators, and landowners to educate on the new rules and promote statewide FPA compliance.

Looking ahead

The Training Team plans to continue meeting the need for FPA training, build a Forest Resources Division eLearning shelf stock, and develop curriculum to support statewide forestry education for new and existing hires. Subject matter experts will guide the planning and development of production, training materials, and Q&A to support field staff regionally and statewide.

Building on our relationships with Federal, State, and NGO partners through collaboration and supportive learning helps maintain compliance and best practices when educating and practicing sustainable forestry. Sharing learning materials, hosting, outreaching, and participating in educational events will provide the consistency of messaging with ODF and affiliated partners as we intersect in applied forestry.
