The Oregon Clean Vehicle Rebate Program reopened on Thursday, May 22, 2025. Vehicles must be purchased or leased on or after that date and while the program is open to be eligible for the rebate. Any vehicles purchased or leased before May 22, 2025 are NOT eligible to apply for Oregon Clean Vehicle Rebates. If the program must close, DEQ will announce the date 30 days in advance. # **OCVRP** Ineligible Vehicles

Vehicles must meet specific program requirements to be eligible to receive a rebate under the Rebate Program, per the statute and regulations (Oregon Administrative Rule <u>340-270</u>). Those requirements include the following:

- Be a battery electric vehicle, plug-in hybrid electric vehicle, electric motorcycle, or a neighborhood electric vehicle ("eligible vehicle"), as those terms are defined in statute and rule.
- Have a base MSRP of \$50,000 or less.
- Have a gross vehicle weight rating (GVRW) of 8,500 pounds or less.
- Meet super ultra-low emission vehicle standards for exhaust emissions, as certified to standards in California Code of Regulations, Title 13, section 1961(a)(4)(2003).
- Has an onboard electrical energy storage device with useful capacity of 10 or more miles of urban dynamometer driving schedule range.

Based on its understanding of the statutes and rules laying out the Oregon Clean Vehicle Rebate Program, DEQ currently believes the following vehicles do not quality as "eligible vehicles":
