## Asset-Controlling Supplier Designation Application

In accordance with OAR 340-215-0120 (7), people who own or operate inter-connected electricity generating facilities or has exclusive rights to claim electricity from these facilities even though they do not own them, may request to be designated by the Oregon Department of Environmental Quality (DEQ) as an asset-controlling supplier (ACS), provided that applicants seeking designation adhere to the requirements of OAR Division 215.

In addition to submitting the applicable data emissions reports, those seeking ACS designation must also submit this application and supplemental attachments listed below by the emissions reporting deadline of each year to Your DEQ Online for DEQ to calculate and publish a supplier-specific system emission factor. ACS emission factors will be calculated according to OAR 340-215-0120 (6)(b) for designated asset-controlling suppliers.
