

## Public Assistance Damage Assessment Guidelines

Category	Purpose	Eligible Activities-examples
A: Debris Removal	Clearance of trees and woody debris; building wreckage; sand, mud, silt, and gravel; vehicles; and other disaster-related material deposited on public and, in very limited cases, private property	<ul> <li>Debris removal from a street or *highway to allow the safe passage of emergency vehicles</li> <li>Debris removal from public property to eliminate health and safety hazards         <ul> <li>*Including debris removal from Rural Major Collectors &amp; above</li> </ul> </li> </ul>
B: Emergency Protective Measures	Measures taken before, during, and after a disaster to save lives, protect public health and safety, and protect improved public and private property IDA include force account overtime labor, equipment usage, contracts and materials. If hired temporary employees include straight time labor	<ul> <li>Emergency Operations Center activation</li> <li>Warning devices (barricades, signs, and announcements)</li> <li>Search and rescue</li> <li>Security forces (police and guards)</li> <li>Construction of temporary levees</li> <li>Sandbagging</li> <li>Bracing/shoring damaged structures</li> <li>Mass Sheltering costs (when conducted by eligible applicant)</li> <li>Emergency repairs (temporary repairs)</li> <li>Removal of health and safety hazards</li> <li>Provision of food, water and ice for distribution</li> </ul>
C: Roads and Bridges	Repair of roads, bridges, and associated features, such as shoulders, ditches, culverts, lighting and signs *Note if under FHWA authority – Rural Major Collector and above is not eligible under FEMA Public Assistance and may not be included in threshold	<ul> <li>Eligible work includes: repair to surfaces, bases, shoulders, ditches, culverts, low water crossings, and other features, such as guardrails.</li> <li>*Document road name and mile post for damages</li> <li>*Road Functional Classification, Rural Major Collector and above (FHWA authority) – Function classification available at following ODOT links</li> <li>https://www.oregon.gov/odot/Data/Pages/Functional-Class.aspx#NHS OR https://gis.odot.state.or.us/transgis/</li> </ul>
D: Water Control Facilities	Repair of irrigation systems, drainage channels, and pumping facilities. Repair of levees, dams, and flood control channels fall under Category D, but the eligibility of these facilities is restricted * note if under USACE or NRCS authority(may not be included in threshold)	<ul> <li>Channel alignment</li> <li>Recreation</li> <li>Navigation</li> <li>Land reclamation</li> <li>Fish and wildlife habitat</li> <li>Interior drainage</li> <li>Irrigation</li> <li>Erosion prevention</li> <li>Flood control</li> </ul>

Category	Purpose	Eligible Activities-examples
E: Buildings and Equipment	Repair or replacement of buildings, including their contents and systems; heavy equipment; and vehicles * If a facility is insured, note deductible amount when submitting IDA	<ul> <li>Buildings, including contents such as furnishings and interior systems such as electrical work</li> <li>Replacement of pre-disaster quantities of consumable supplies and inventory. Replacement of library books and publications.</li> <li>Removal of mud, silt, or other accumulated debris is eligible, along with any cleaning and painting necessary to restore the building.</li> <li>All types of equipment, including vehicles, may be eligible for repair or replacement when damaged as a result of the declared event.</li> </ul>
F: Utilities	Repair of water treatment and delivery systems; power generation facilities and distribution lines; and sewage collection and treatment facilities	<ul> <li>Restoration of damaged utilities.</li> <li>Temporary as well as permanent repair costs can be reimbursed</li> </ul>
G: Parks, Recreational Facilities, and Other Items	Repair and restoration of parks, playgrounds, pools and public cemeteries. This category also is used for any work or facility that cannot be characterized adequately by Categories A-F	<ul> <li>Roads, buildings, and utilities within those areas and other features, such as playground equipment, ball fields, swimming pools, tennis courts, boat docks and ramps, piers, and golf courses.</li> <li>Grass and sod are eligible only when necessary to stabilize slopes and minimize sediment runoff.</li> <li>Repairs to maintained public beaches may be eligible in limited circumstances</li> </ul>
I: Building Code and Floodplain Management Administration and Enforcement	Administration and enforcement work to ensure that repair and replacement of damaged facilities and infrastructure meet adopted regulatory requirements, such as those set forth in floodplain management regulations and building codes. Additional resources are spent reviewing permits, inspecting repair work, and enforcing adopted regulations	<ul> <li>Eligible for a period of no longer than 180 days after the date of the major disaster declaration</li> <li>Building code administration</li> <li>Code enforcement</li> <li>Floodplain management ordinance and enforcement</li> <li>Substantial damage determinations</li> </ul>

Only states, local government agencies and authorities, public utilities, and certain non-profit organizations may be eligible for Public Assistance grants.
