

MARIJUANA PRODUCER WATER USE FORM

This document is intended to fulfill the requirements in OAR 845-025-1030(3)(e)(C) and (4)(f)(B) and to serve as proof to the Oregon Liquor and Cannabis Commission (OLCC) that the source of water described on this form is a source that does or does not require a water use permit or certificate from the Oregon Water Resources Department (OWRD) and is intended for use in the cultivation of marijuana for commercial purposes. This determination is based in part upon the information provided by the producer. OWRD staff may need to conduct a site visit to determine if the proposed water use is consistent with Oregon water law. Incorrect or falsified information from a producer or a producer's representative shall invalidate this form and may be grounds for OWRD and/or OLCC to take administrative action.

OWRD makes no assurances about the sufficiency of the water source described on this form to meet the cultivation needs of the producer. Producers must ensure their water source is legal and sufficient to serve all their operation's needs. This form does not constitute evidence that the producer is in compliance with Oregon's water laws nor provide any assurance that other sources of water may be legally used by the producer in the cultivation or processing of marijuana.
